

Welcome to the Framingham Centre Nursery School's Summer Extension Program 2024

We are pleased to announce that we are offering 10 weeks of summer programming. Families can register for 1-week, multiple weeks (they do not need to be consecutive weeks) or the full 10 weeks. We are offering special pricing for enrollment for all 10 weeks.

Summer enrollment is open to children ages 2.9 to 7 years old (children entering into 1st grade in September). Children do not need to be enrolled in the school year program to attend for the summer.

The Summer program starts on June 17, 2024 and runs through August 23, 2024. Each week is 5-days with either a 9AM to 1PM or 9AM to 3PM option. Week 1 is only 4 days (Wednesday June 19th is a holiday) and week 3 is only 3 days (Thursday July 4th and Friday July 5th - closed in observance of the holiday).

PAYMENT AND REFUND POLICY

To enroll for the Summer Program, complete this registration form. There is a \$20 registration fee per child that will be billed at the time of enrollment.

Summer tuition will be due on June 1st for the weekly enrollment option. Tuition for the full 10 weeks will be billed in 3 payments – June 1st, July 1st and August 1st.

REFUNDS: For weekly sessions, if notification of withdrawal is given 3 weeks prior to the date of enrollment, tuition will be refunded minus a \$50 service fee or, if space allows, the tuition can be applied to a different week.

For full summer enrollment, if notification of withdrawal is received by June 10th, the 1st tuition payment will be refunded minus a \$50 service fee. If notification of withdrawal is given between June 11th and June 28th, the 1st tuition payment is not refundable and the 2nd and 3rd payments will be waived. If notification of August withdrawal is be given by July 1st, the 3rd tuition payment will be waived. If notification of withdrawal is given after July 2nd, tuition is not refundable.

• The <u>Massachusetts Department of Early Education and Care (EEC)</u> is the licensing authority by which Framingham Centre Nursery School and its Summer Extension Program are regulated.
